Purpose

The purpose of this enforceable undertaking is to document the undertakings given to SafeWork NSW and accepted by SafeWork NSW pursuant to Part 11 of the Work Health and Safety Act 2011 (WHS Act) in connection with matters relating to alleged contraventions of the WHS Act or the Work Health and Safety Regulations 2011 (the Regulations). The Agreed Terms of the Enforceable Undertaking are set out below.

b. Commencement

This Undertaking comes into effect when:

- i. the Undertaking is executed by Ladex Construction Group Pty Ltd;
- ii. SafeWork NSW accepts the executed Undertaking (Commencement Date).

c. Duration

- i. Section 5 identifies timeframes for the completion of each strategy identified in this enforceable undertaking.
- ii. the enforceable undertaking will be concluded on written advice from SafeWork NSW to Ladex Construction Group Pty Ltd when all requirements of the undertaking have been satisfactorily executed.

Section 2 - The alleged contravention

a. Details of the alleged contravention

It is alleged by SafeWork NSW that on 20 February 2020, Ladex Construction Group Pty Ltd failed to discharge its obligations as a person conducting a business or undertaking under section 19(1) and 32 of the WHS Act in that it did not ensure so far as reasonably practicable the health and safety of workers and/or others.

b. Details of the events surrounding the alleged contravention

On 20th February 2020, one of Ladex Construction Group Pty Ltd sub-contractors' labourers was seriously injured following a fall through an open penetration from the upper floor level. The open penetration where a staircase was to be installed had approximately two thirds protected by an aluminium framework that went from floor to ceiling.

c. The details of any injury that arose from the alleged contravention

The worker suffered injuries as a result of the incident

d. An acknowledgement that SafeWork NSW alleged a contravention has occurred

It is acknowledged by Ladex Construction Group Pty Ltd that SafeWork NSW has alleged that Ladex Construction Group Pty Ltd has contravened sections 19(1) of the WHS Act.

e. A statement of regret that the incident occurred

Ladex Construction Group Pty Ltd regrets that the incident on 20 February 2020 occurred and the Worker sustained injuries as a result of the incident.

Note: the above is not an admission of guilt

f. Prior work health and safety convictions

Ladex Construction Group Pty Ltd has had no prior work health and safety convictions in NSW or other work health safety jurisdictions.

g. The details of the type of workers compensation provided (if the injured person(s) is a worker of the person)

Workers' compensation was provided by the employer of the injured worker, a subcontractor of Ladex Construction Group Pty Ltd.

h. The details of the support provided, and proposed to be provided, to the injured person(s) to overcome the injury/illness

The worker was employed by a subcontractor of Ladex Construction Group Pty Ltd at the time of the incident.

Ladex Construction Group employees have been included in regular consultation on strategies and initiatives of the proposed undertaking to ensure acceptance, and a commitment to the proposed initiatives and the identification of areas for improvement.

Ladex Construction Group will continue to consult with all relevant stakeholders throughout the development and implementation of the strategies that will contribute to improved work health and safety in the workforce, industry, and the community.

g. Statement regarding relationships with other parties

Ladex Construction Group Pty Ltd advises that there are no known current relationships with any of the beneficiaries outlined in the enforceable undertaking, other than the current employees of Ladex Construction Group.

Ladex Construction Group Pty Ltd grants SafeWork NSW a permanent, irrevocable, royalty-free, worldwide, non-exclusive license to use, reproduce, distribute, electronically transmit, electronically distribute, adapt, and modify any materials developed as a result of this enforceable undertaking.

Ladex Construction Group Pty Ltd acknowledges that the responsibility for demonstrating compliance with this undertaking rests with Ladex Construction Group Pty Ltd. Evidence to demonstrate compliance with the terms will be provided to SafeWork NSW by the due date for each Strategy item identified in Section 5.

Ladex Construction Group Pty Ltd acknowledges that SafeWork NSW may undertake other compliance monitoring activities to verify the evidence that is provided for each Strategy item identified in Section 5. The evidence provided to demonstrate compliance with the undertaking will be retained by Ladex Construction Group Pty Ltd until advised by SafeWork NSW that the undertaking has been completely discharged.

Ladex Construction Group Pty Ltd acknowledges that SafeWork NSW may initiate additional compliance monitoring activities, such as inspections, as considered necessary.

Ladex Construction Group Pty Ltd acknowledges that should there be any delay in the delivery or compliance of the Enforceable Undertaking this will be subject to mutual agreement (confirmed in writing) between Ladex Construction Group Pty Ltd and SafeWork NSW.

l. Inconsistent Statements

Ladex Construction Group Pty Ltd commits that it will not make any statement or otherwise imply anything that is inconsistent with the statements, commitments or acknowledgements contained in this Undertaking and will take steps to ensure its representatives, employees and officers do not make any such statements.

m. Reliance on Commitments

Ladex Construction Group Pty Ltd acknowledges that SafeWork NSW may rely upon the commitments and statements set out in Section 4 (a), (b) and (c) above when making decisions regarding enforcement action if Ladex Construction Group Pty Ltd fails to comply with its workplace relations obligations in the future, including but not limited to any failure to comply with its obligations under this Undertaking.

n. Withdrawal or variation

Ladex Construction Group Pty Ltd may with the written agreement of SafeWork NSW withdraw or vary the undertaking in accordance with section 221 of the Work Health and Safety Act 2011.

o. Acknowledgement of Enforceable Undertakings Guidelines and Contravention of the Undertaking

Ladex Construction Group Pty Ltd has read and understood SafeWork NSW Enforceable Undertakings Guidelines.

Ladex Construction Group Pty Ltd acknowledges that if Ladex Construction Group Pty Ltd contravenes any of the terms of this Enforceable Undertaking, SafeWork NSW may apply to the District Court for an order in accordance with section 220 of the Work Health and Safety Act 2011.

Strategy 4 - WHS Coordinator role

Summary:

Ladex Construction Group Pty Ltd historically had a WHS Coordinator role that spends a considerable amount of time (approx. 60%) working in a WHS supervisor capacity. This has restricted the ability of the role to focus exclusively on WHS across the business. Ladex Construction Group Pty Ltd recognises the need for a fulltime WHS Coordinator role and undertakes to recruitment such a role that is dedicated to WHS. To ensure that the creation of the WHS Coordinator role does not reduce the current level of site supervisors' further resources have already been applied in that area to strengthen the level of supervision across the business.

WHS outcome and beneficiaries:

A dedicated WHS Coordinator role will ensure, particularly as a principal contractor, that Ladex Construction Group Pty Ltd has a strong commitment to WHS and sets and maintains high standards across its business and its work sites. The role will provide Ladex Construction Group Pty Ltd staff, and its subcontractors, with a higher level of access to the WHS Coordinator to seek advice and support in relation to WHS matters.

Strategy 5 - WHS capability building

Summary:

Ladex Construction Group Pty Ltd undertakes to build the WHS capability of its employees who work in high-risk areas, specifically those who work at heights or in confined spaces. In addition, Ladex Construction Group Pty Ltd has identified the need to strengthen the level of WHS risk assessment capabilities across the business. To lift capability across these areas Ladex Construction Group Pty Ltd will provide the following training to identified staff and subcontractors:

- Working at heights training
- Confined spaces training
- WHS risk assessment training

During the initial response to the incident a small of workers completed training in relation to working at heights and confined spaces. This strategy aims to upskill the remaining workforce in these areas, as well as provide refresher to those who have completed such training in the past.

Please Note – Some employees have previously been trained in Working at Heights and Confined Spaces; however, we are requiring these employees to undergo a refresher course in both elements as it's been more than 2 years since completing the course

The training contained in the strategy has consciously been spread across a two-year period to minimise disruption to the day-to-day operations of the business. Ladex Construction Group Pty Ltd has also made the conscious decision to use local training providers in the delivery of the training wherever possible to support the local business community.

WHS outcome and beneficiaries:

Falls from heights and confined spaces are known serious risks in the construction industry and a priority highlighted in the Work Health and Safety Roadmap for NSW 2022. The identified training will provide Ladex Construction Group Pty Ltd and identified subcontractors with increased skills and capability in relation to managing the risks associated. Risk assessment training will ensure employees are endowed with extra knowledge and skills to identify hazards and apply risk principles to rank hazards using various types of risk matrixes, ultimately leading to more specific and relevant risk assessments occurring across the business and on work sites. Those who complete the training will acquire transferrable skills and knowledge across industry.

To ensure the safety messaging resonates with its workforce Ladex Construction Group Pty Ltd will both consult with its workforce and engage a suitably qualified marketing agency to assist in the development of the final agreed safety messaging. Ladex Construction Group Pty Ltd has already had preliminary discussions with a marketing agency in relation to this strategy and has again made the conscious decision to work with a local provider to support the local business community.

In addition, Ladex Construction Group Pty Ltd undertakes to develop and deliver a local radio campaign that targets the construction industry to increase the awareness of the risks associated with working at heights, particularly to younger workers. The radio campaign will

deliver 240 radio advertisements across a period of 3 months on the network – 2 local stations construction Group Pty Ltd intend to deliver 4 separate advertisements with differing scenarios working with the local radio network.

WHS outcome and beneficiaries:

Raising the awareness levels of the importance of safety in the workplace and industry is a responsibility Ladex Construction Group Pty Ltd takes seriously. The purpose of this strategy is to promote safety in the workplace and throughout the local industry through consistent and strategic messaging that is visible to all Ladex Construction Group Pty Ltd employees, its subcontractors, other industry workers on site, and the wider community, along with a targeted radio campaign.

Summary:

Youth workers continue to be one of those at the highest risk of injury in the workplace. The introduction of an annual safety award for apprentices will help to promote the importance of safety to this at-risk group.

On 20 February 2020, a worker, employed by a subcontractor of Ladex Construction Group Pty Ltd, fell through an open penetration on a Ladex Construction Group Pty Ltd site at Adelong. The worker suffered serious injuries as a result of the fall.

SafeWork NSW investigated the incident and subsequently alleged that Ladex Construction Group Pty Ltd contravened section 19(1) and 32 of the Work Health and Safety Act 2011.

SafeWork NSW has accepted an enforceable undertaking from Ladex Construction Group Pty Ltd, ACN: 082 076 784 in accordance with Part 11 of the Work Health and Safety Act 2011 in relation to the abovementioned alleged contravention. This notice has been placed under the terms of the Enforceable Undertaking and acknowledges acceptance of the Enforceable Undertaking by Ladex Construction Group Pty Ltd.

The undertaking requires the following actions:

- WHS leadership training
- Dedicated WHS Coordinator role
- Workplace WHS capability building
- Safety awareness and promotional messaging including radio campaign
- Sponsorship and presentation of local TAFE safety awards for apprentices, including sharing lesson learnt
