Formwork Safety in Construction

This checklist can be used by principal contractors and site supervisors to manage the risks of formwork and formwork activities on construction sites.

Principal contractors and builders have a duty to provide and maintain a working environment that is safe and without risks to health and safety, so far as is reasonably practicable. This includes ensuring proper planning, consultation and communication, safe systems of work, the right safety equipment at the right time and plant that is adequately maintained.

The major risks related to formwork include falls from formwork edges or through penetrations, being hit by falling timbers or crane loads, formwork collapse and contact with powerlines. This site supervisor formwork safety checklist is designed to help identify potential issues or risks with formwork on a construction site. It is NOT intended to be exhaustive and reference should be made to appropriate legislation, standards, Codes of Practice and Guides.

On-the-spot fines of up to \$3,600 for businesses and \$720 for individuals may be issued to those placing workers lives at risk by not adequately protecting them when working at heights, or for undertaking high risk work activities without holding the appropriate high risk work licence eg scaffolding, crane operations.

If you answer no to any of the following questions, you may be in breach of the work health and safety legislation, or its associated Codes of Practice or Australian Standards.
