# **Purpose**

The purpose of this enforceable undertaking is to document the undertakings given to SafeWork NSW and accepted by SafeWork NSW pursuant to Part 11 of the Work Health and Safety Act 2011 (WHS Act) in connection with matters relating to alleged contraventions of the WHS Act or the Work Health and Safety Regulations 2011 (the Regulations). The Agreed Terms of the Enforceable Undertaking are set out below.

#### b. Commencement

This Undertaking comes into effect when:

- i. the Undertaking is executed by Dragon Glass Lamination Pty Ltd;
- ii. SafeWork NSW accepts the executed Undertaking (Commencement Date).

# c. Duration

- i. Section 5 identifies timeframes for the completion of each strategy identified in this enforceable undertaking;
- ii. the enforceable undertaking will be concluded on written advice from SafeWork NSW to Dragon Glass Lamination Pty Ltd when all requirements of the undertaking have been satisfactorily executed.

# Section 2 – The alleged contravention

# a. Details of the alleged contravention

It is alleged by SafeWork NSW that on 27 November 2019, Dragon Glass Lamination Pty Ltd failed to discharge its obligations as a person conducting a business or undertaking under section 19(1) of the WHS Act in that it did not ensure so far as reasonably practicable the health and safety of workers and/or others.

# b. Details of the events surrounding the alleged contravention

The alleged contravention occurred when a worker was crushed by unsecured glass panels that fell from an A-frame they were being stored on.

#### c. The details of any injury that arose from the alleged contravention

The worker suffered multiple fractures to the lower areas of their body and other soft tissue injuries. Another worker sustained minor cuts as they jumped clear of the falling glass panels.

### d. An acknowledgement that SafeWork NSW alleged a contravention has occurred

It is acknowledged by Dragon Glass Lamination Pty Ltd that SafeWork NSW has alleged that Dragon Glass Lamination Pty Ltd has contravened sections 19(1) and 32 of the WHS Act.

# e. A statement of regret that the incident occurred

Dragon Glass Lamination Pty Ltd regrets that the incident on 27 November 2019 occurred and the Workers sustained injuries as a result of the incident.

#### f. Prior work health and safety convictions

Dragon Glass Lamination Pty Ltd has had no prior work health and safety convictions in NSW or other work health safety jurisdictions.

# h. A commitment to participate constructively in all compliance monitoring activities of the undertaking

Dragon Glass Lamination Pty Ltd acknowledges that the responsibility for demonstrating compliance with this undertaking rests with Dragon Glass Lamination Pty Ltd. Evidence to demonstrate compliance with the terms will be provided to SafeWork NSW by the due date for each Strategy item identified in Section 5.

Dragon Glass Lamination Pty Ltd acknowledges that SafeWork NSW may undertake other compliance monitoring activities to verify the evidence that is provided for each Strategy item identified in Section 5. The evidence provided to demonstrate compliance with the undertaking will be retained by Dragon Glass Lamination Pty Ltd until advised by SafeWork NSW that the undertaking has been completely discharged.

Dragon Glass Lamination Pty Ltd acknowledges that SafeWork NSW may initiate additional compliance monitoring activities, such as inspections, as considered necessary.

Dragon Glass Lamination Pty Ltd acknowledges that should there be any delay in the delivery or compliance of the Enforceable Undertaking this will be subject to mutual agreement (confirmed in writing) between Dragon Glass Lamination Pty Ltd and SafeWork NSW.

# i. A commitment regarding linking the strategy and promotion of benefits to the enforceable undertaking

Dragon Glass Lamination Pty Ltd commits that it will not make any statement or otherwise imply anything that is inconsistent with the statements, commitments or acknowledgements contained in this Undertaking and will take steps to ensure its representatives, employees and officers do not make any such statements.

#### l. Reliance on Commitments

Dragon Glass Lamination Pty Ltd acknowledges that SafeWork NSW may rely upon the commitments and statements set out in Section 4 (a), (b) and (c) above when making decisions regarding enforcement action if Dragon Glass Lamination Pty Ltd fails to comply with its workplace relations obligations in the future, including but not limited to any failure to comply with its obligations under this Undertaking.

#### m. Withdrawal or variation

Dragon Glass Lamination Pty Ltd may with the written agreement of SafeWork NSW withdraw or vary the undertaking in accordance with section 221 of the Work Health and Safety Act 2011.

n. Acknowledgement of Enforceable Undertakings Guidelines and Contravention of the Undertaking Dragon Glass Lamination Pty Ltd has read and understood SafeWork NSW Enforceable Undertakings Guidelines.

Dragon Glass Lamination Pty Ltd acknowledges that if Dragon Glass Lamination Pty Ltd contravenes any of the terms of this Enforceable Undertaking, SafeWork NSW may apply to the District Court for an order in accordance with section 220 of the Work Health and Safety Act 2011.

# Strategy No.3 - Targeted audit strategy - Glass handling, storage and machinery operation

# **Summary:**

Dragon Glass Lamination Pty Ltd will identify and detail gaps in the handling, storage, and transport of glass, and, in the operation of machinery by determining the level of conformance with and implementation of its current WHS management systems and procedures against WHS legislative and Dragon Glass Lamination Pty Ltd's operative requirements, focusing on the following areas:

- General handling and movement of glass including lifting, loading, unloading, and exclusion zones
- Storage of glass including securing glass, stock control and weight loadings
- Operation of machinery including training, operation, supervision and traffic management
- Documented procedures and systems of work
- WHS Training and supervision.

The audit will measure the level of compliance from Dragon Glass Lamination Pty Ltd against the following standards considering the tasks being completed and any other relevant industry specific reference material:

- SafeWork NSW Code of Practice Managing the risks of plant in the workplace
- SafeWork NSW Code of Practice Hazardous manual tasks
- SafeWork NSW Code of Practice How to work manage health and safety risks

Dragon Glass Lamination Pty Ltd will identify and detail improvement suggestions (based on identified gaps) to assist in the development of a corrective action plan focused on improved performance across Dragon Glass Lamination Pty Ltd's operations in:

- Glass handling and storage
- Operation of machinery.

# WHS outcome and beneficiaries:

The audit and corrective action plan will provide clear direction for areas of improvement for Dragon Glass Lamination Pty Ltd and its workers in the safe handling and storage of glass and operation of machinery. This will ultimately result in a more educated and safer workplace for workers.

Dragon Glass Lamination Pty Ltd will provide accredited training in the following areas to increase the level WHS knowledge and skills of its workforce:

- Machinery operations (for identified employees that do not currently have the relevant skills or relevant high-risk work licence, and refresher training for those who do) for:
  - o forklift truck
  - o scissor lift
  - o overhead crane (bridge and gantry crane operation)
  - dogging
- WHS risk management training

Dragon Glass Lamination Pty Ltd fully understands it's WHS obligations to provide workers with the required training and instruction to complete their job roles. This strategy recognises the value of providing workers with a broader understanding of not only their own roles but the roles of others in the workplace, and the risks associated with those roles. Through providing the workforce with increased knowledge and exposure to information about the risks collectively across the workplace, Dragon Glass Lamination Pty Ltd is aiming to build a higher level of agility and the collective WHS capability of the business. In addition, employees that complete the training will acquire transferrable skills and knowledge that can be used across industry.

# <u>Strategy No.5 – Industry safety videos</u>

#### Summary:

Dragon Glass Lamination Pty Ltd, in consultation with the Australian Glass and Window Association (AGWA), will produce a series of 4 educative safety training videos for industry. The videos will focus on the safe handling of glass. The specific topics covered in the videos will be:

- manual lifting of glass (one and two person lift)
- safe operation of an overhead crane or lifting equipment
- storage and accessing glass in racks
- A fourth topic to be determined in consultation with AGWA after the completion of the initial audit in strategy 3 of this enforceable undertaking

The videos will be produced using Dragon Glass Lamination Pty Ltd staff at the factory in Wagga Wagga. Dragon Glass Lamination Pty Ltd will engage an experienced Educational Designer and training resource developer to oversee the pedagogical, logistical and technical design aspects of the video productions. Dragon Glass Lamination Pty Ltd will purchase digital editing software and bring the post-production 'in-house' to reduce costs, facilitate greater flexibility and allow subsequent re-editing and processing as the digital media landscape evolves. The strategy will include the development, production and promotion of the videos.

The intellectual property of the videos will be held jointly with SafeWork NSW and AGWA to allow AGWA to use the videos on the AGWA website for its industry members and in AGWA training courses.

# WHS outcome and beneficiaries:

The industry currently has a lack of relevant glass industry safety videos that are appropriate and accessible. This strategy aims to address that issue and is supported by AGWA. The videos will provide general safety information in a format that is easily accessible and caters for workers from a non-English speaking background. Where applicable the videos will be produced in a style that promotes interaction between the teacher/trainer and learner to stimulate discussion and wider thinking about the risks involved with working with glass. Where applicable to the task being completed, the videos will reference and/or highlight existing safety material developed by industry or regulators to promote such safety material.

# Annexure 1 - Public Notice of SafeWork NSW's acceptance of undertaking

Notice of Acceptance of an Enforceable Undertaking under Part 11 of the Work Health and Safety Act 2011.

On 27 November 2019, a worker employed by Dragon Glass Lamination Pty Ltd suffered serious injuries after being crushed by unsecured glass panels which fell from an A-frame at a factory in Goulburn. Another worker suffered minor injuries in the incident.

SafeWork NSW investigated the incident and subsequently alleged that Dragon Glass Lamination Pty Ltd contravened section 19(1) and 32 of the Work Health and Safety Act 2011.

SafeWork NSW has accepted an enforceable undertaking from Dragon Glass Lamination Pty Ltd, ACN 624 616 968, in accordance with Part 11 of the Work Health and Safety Act 2011 in relation to the abovementioned alleged contravention. This notice has been placed under the terms of the Enforceable Undertaking and acknowledges acceptance of the Enforceable Undertaking by Dragon Glass Lamination Pty Ltd.

The undertaking requires the following actions:

- Targeted audit focussed on glass handling, storage and operation of machinery including the implementation of any corrective actions
- WHS training to increase staff skills and knowledge
- Development, production, and promotion of four industry safety videos
- Educating industry through sharing lessons learned
